RELEASE AND HOLD HARMLESS AGREEMENT

The undersigned, being of lawful age, acknowledges there are great hazards, dangers and risks of injury or death associated with horses and horseback riding, including, but not limited to the risk of falling from a horse or being thrown from a horse, striking an object while on a horse or being kicked by a horse. I know that horses even under careful supervision are unpredictable. Knowing and appreciating this danger, I desire to receive riding lessons, ride, lease or board a horse (or, as the case may be, have my child receive riding lessons, ride, lease or board a horse) at Lakefield Farm LLC. Therefore, in consideration of the opportunity to ride horses at Lakefield Farm LLC, to participate in equestrian activities, either there or elsewhere, and/or board a horse and for other good and valuable consideration, I do hereby:

RELEASE, Lakefield Farm LLC, a Limited Liability Company, Rosanne, Don, & Leanne Korinek, Paula and Jack Curtis, individually and as members and officers, their employees or agents, successors, and assign, and all other person, corporations, associations, or partnership-s and their insurers (hereinafter "Lakefield Farm") FROM ANY AND ALL CLAIMS whatsoever which I may hereafter incur on account of or in any way growing out of bodily and/or personal injury involving me or members of my family or guests and arising out of any horse related activities associated with Lakefield Farm.

I further COVENANT to never institute any suit or action against the above named for reason of any claim relating to such activities.

I shall INDEMNIFY and save Lakefield Farm harmless against any and all further claims and damages, costs or expenses which might result from any accident or injury to me, members of my family or guests, or any horses which may result from negligence of any of the above or third parties or any combination thereof.

I also agree and represent that I shall wear protective head gear with a chin strap at all times while mounted on a horse at Lakefield Farm, which head gear shall be acceptable to Lakefield Farm, in it's sole discretion in the quality and safety features of the protective head gear.

"NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from inherent risks of equine activities as defined in section 895.481(1)(e) of the Wisconsin Statutes."
